A. Criteria for selection of the travel agent:-

- a) Having trade license,
- b) GST registration,
- c) PAN card,
- a) Balance sheet / IT return for last three years.
- b) Having furnished office equipped with computer, internet, phone and eligible manpower.

B. Credentials.

- a). Established travel agent, tour operator, hotel booking agent etc work continuously for five years.
- b). Having authorisation from any of the state tourism, state tourism development corporation, Nodal organisations (IATA, TAAI, IATO, TAB, BTA, etc).

C Security Deposit.

A sum of Rs30000.00(Rupees Thirty Thousand) only to be kept as a security deposit and same to be refunded without any interest at the time of termination or withdrawal of the agency.

D. **Booking Procedure.**

Any booking to be done from the on line booking system of Benfish and Benfish will provide USER ID to keep track of the individual authorised agents booking. At the end of the month / quarter Authorised Agent has to submit the statement for those customer who are already used their booking or make cancellation, before submission of that statement. On received of the statement and examination thereafter, Travel Agent Commission (TAC) would be disbursed.

E. Travel Agent Commission.

F. If selected by the Benfish, Travel Agent has to execute an agreement on non-judicial stamp paper with Benfish.
